## 3. Public Commentary

Mark Werenko of 62-64 French Street asked the Board to review the increase in his sewer fee due to a leak during the winter quarter which caused the usage to be extremely high. Mark stated that once the leak was found and repaired, the usage went down drastically.

Gary Devoe, representing Heminway Associates located at 429 Main Street asked the Board to review their sewer fee because a house fire took place on April 7<sup>th</sup>, 2017 and the house was vacant for half of the quarter the bill was based upon.

## 4A. Discussion and possible approval of Sewer Fee Adjustment for 62-64 French Street

The Board discussed and reviewed the usage for 62-64 French Street due to a leak which caused the normal winter usage to increase. The leak has since been repaired. The Board decided to adjust the sewer fee for 62-64 French Street for the next 4 quarters beginning with the 8/1 bill using the average usage of 69,250 gallons.

**MOTION:** By Mr. Alfonso Bernardi and seconded by Mr. Robert Yerger to approve a sewer fee adjustment for 62-64 French Street for the next 4 quarters beginning with the 8/1 bill using the average winter usage of 69,250 gallons.

The Board discussed and reviewed the current sewer fee for 429 Main Street. The Board decided to adjust the sewer fee for 429 Main Street, dividing his sewer fee in half basing it on 28,575 gallons.
