4a. Discussion of 85 DeForest Street

The property had a toilet leak during the January/February 2020 timeframe, approximately 29,160 gallons over two months. The leak was fixed in March. After a brief discussion it was decided that Mr. Krawchuk's sewer bill would be adjusted going forward to be based off of 4,383 gallons/month until it is recalculated in July 2021.

MOTION: By Mr. Lehner and seconded by Mr. Yerger to adjust Mr. Krawchuk's sewer charge from \$124.13 to \$37.34 per month.

Mr. Tanuis reported that the relining project is done. Final paving will be in approximately three weeks. Manhole sealing project is done. Flushing hydrants has begun.
