6A. Discussion and Possible Approval of a Sewer Fee Adjustment for 162 Edward Avenue

Water consumption at 162 Edward Avenue has been erratic over the past 2 years with the highest consumption during the winter quarter of 2024. No explanation has been provided for the high usage. Water consumption since the winter quarter of 2024 has gone down. The current sewer fee is based on the peak usage. The Board discussed and reviewed the consumption at 162 Edward Avenue and agreed to adjust the sewer fee from \$790.89 to \$478.58 per month for the January 2025 through June 2025 bills. In July 2025 the sewer fee will be recalculated based on the water consumption during the winter quarter of 2025.

MOTION: By Mr. James Lehner and seconded by Mr. Robert Yerger to approve the sewer fee adjustment for 162 Edward Avenue from \$790.89 to \$478.58 per month for the January 2025 through June 2025 bills.
